**Pro-Novice: \$25 per day SJVBCA MEMBERS (\$30 NON-MEMBERS)** Course: Outrun, lift, fetch, drive through two sets of panels, pen. (150+ yard outrun).

**Novice-Novice: \$20 per day SJVBCA MEMBERS (\$25 NON-MEMBERS)** Course: Outrun, lift, fetch, pen.

**Ranch Class: \$25 per day SJVBCA MEMBERS - \$30 Non-Members.** Course: Outrun, lift, fetch, drive through two sets of panels, pen. 150 + yard outrun.

All classes will run only once, to allow time for Annual Meeting. OPEN RANCH CLASS will run after lunch.

**COURSES MAY CHANGE PRIOR TO START OF RUNS at the discretion of the trial committee.**

**HANDLERS MEETING 8 am.**

**Lunch will be provided.**

Time permitting, at the end of each day, "**FUN RUNS**", for dogs **under control**, fee \$10 a run for **members** and \$15 for **non-members**. (Membership in SJVBCA is \$25. a year individual, \$35. for family)

**Location:** Jim Oxford Ranch, 24577 Ave. 188, Porterville, California 559-784-2835

The classes will be run on a 5 ac. permanent pasture fenced field, using the ranch working sheep.

**DIRECTIONS TO TRIAL SITE:**

**From South:** Hwy 99 North thru Bakersfield. Take Hwy 65 North to Porterville/Sequoia Parks. Continue on Hwy 65 thru Porterville to Ave 196 at Strathmore. (Signal) Turn right (East) on Ave 196. Go approximately 4 miles East. Turn right (South) on Road 244. Go South approximately ¾ mile to trial site.

**From North:** Hwy 99 South to Tulare. Exit Hwy 137 East to Lindsay. Continue on Hwy 137 thru Lindsay. (Hwy 137 will turn into Hwy 65 at Lindsay curve: Hwy curves Southward).

Continue South on Hwy 65 to Ave 196 at Strathmore (Signal) turn left (East). Follow instructions from signal at Strathmore as above. **Watch for Dog Trial Signs.**
