Two One Day Trials Location: Oxford Ranch, Porterville
Entries will **Open** February 8 and **close** February 20, 2010. **NO REFUNDS** AFTER February 20.
Entries may be limited.

CLASSES WILL RUN IN FOLLOWING ORDER: Pro-Novice, Novice, Nursery, Open

OPEN: \$45 per day. Course: Outrun, lift, fetch, drive through two sets of panels, shed, pen, single.

PRO-NOVICE: \$ 35 per day. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

NURSERY: \$37 per day. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

NOVICE-NOVICE: \$30 per day. Course: Outrun, lift, fetch, drive one panel, pen.

Classes will be run on a 5 ac. Permanent pasture fenced field, using K/SC sheep.

Courses may be changed prior to start of the trial at the discretion of the trial committee.

Directions to the trial:

From the south: Hwy 99 North thru Bakersfield. Take Hwy 65 North to Porterville/Sequoia Parks. Continue on Hwy 65 thru Porterville to Ave. 196 at Strathmore. (signal)

Turn right (east) on Ave. 196. Go approximately 4 miles east. Turn right (south) on Rd. 244. Go South to trial site.

From the North: Hwy 99 South to Tulare. Exit Hwy 137 East to Lindsay. Continue on Hwy 137 thru Lindsay. (Hwy 137 will turn into Hwy 65 at Lindsay curve. Hwy curves southward) Continue south on Hwy 65 to Ave. 196 at Strathmore (signal) turn left (east). Follow directions above. **Watch for Dog Trial Signs.**
